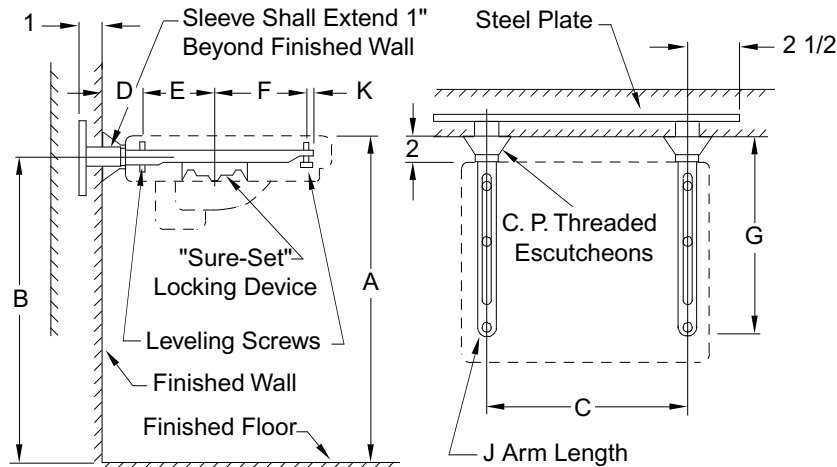


Fig. 0722 (-E) . . . FOR FLAT SLAB LAVATORIES SET ON STEEL PLATE SECURED IN WALL

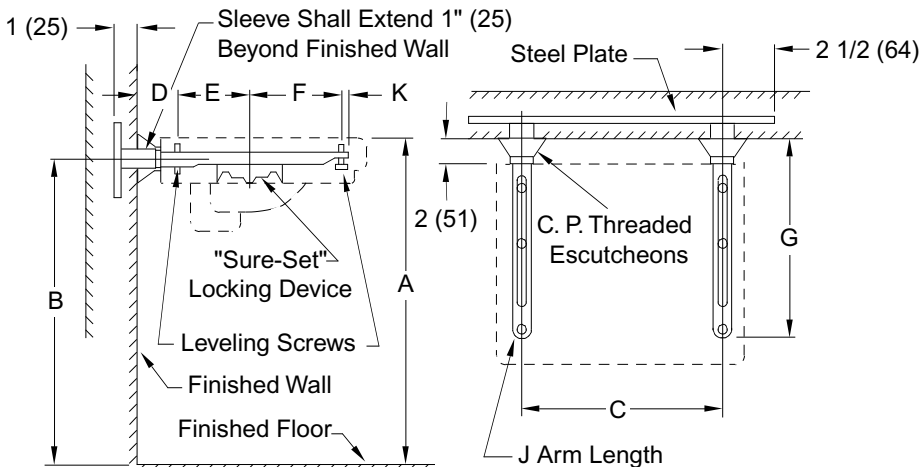


Fig. 0722 (-E) . . . FOR FLAT SLAB LAVATORIES SET ON STEEL PLATE SECURED IN WALL
